Booking Terms and Conditions.

Fees

Open Water Course

The sum of £55 is payable as a non-refundable deposit to book your place on the course and provide you with the Manual and educational pack. The sum of £125 which covers the pool instruction and training, theory and equipment hire is due before your first pool session this is also non-refundable. The final payment of £120 is due 2 weeks before the completion of the 4 Open Water Dives and is non-refundable.

Advance Open Water Course

The sum of £55 is payable as a non-refundable deposit to book your place on the course and provide you with the manual & educational pack. The final sum of £140 which covers the cost of the Open Water dives, equipment, instruction is due the 2 weeks prior to your course date and is non-refundable.

Rescue Course

The sum of £55 is payable as a non-refundable deposit to book your place on the course and provide you with the manual & educational pack. If you already possess a first aid certification then the remainder of £195 which covers the pool instruction, training, theory and equipment hire is due 2 weeks prior to your open water dates. For those partaking in the Rescue & First Aid course the sum of £240 which covers the pool instruction, training, theory, first aid course and equipment hire is due 2 weeks prior to your open water dates.

Divemaster & Speciality Course

The total sum of the course cost is due 2 weeks prior to the course dates and is non-refundable.

3. Cancellation by Client.

4. *All cancellations must be in writing. In the event of cancellations for reasons other than illness or injury (medical certificate required) the following charges apply: -*

<i>More than 6 weeks prior to activity commencement</i>	<i>Loss of deposit only.</i>
<i>Between 6 to 4 weeks prior to activity commencement</i>	<i>75% of activity fee.</i>
<i>Between 4 to 2 weeks prior to activity commencement</i>	<i>FULL activity fee.</i>

Cancellation by Ocean Quest.

5. *Whilst every attempt is made to ensure that courses actually run, we reserve the right to vary or cancel any course. If this should become necessary due to dangerous and / or unsuitable conditions. In the most unlikely event of cancellation by Ocean Quest, monies will be refunded in full or an alternative course date will be offered.*

6. *Ocean Quest shall notify the clients of cancellation not less than five days prior to the commencement of the course where numbers as a result of client (s) cancellation failed to reach a workable minimum for the commencement of the course*

Should an instructor find that a course member/s is being disruptive or jeopardizing the safety of others then that person/s will be asked to leave the course.
